goal of making a positive impact in our community.



TRAILBLAZER COMMISSIONER KEVIN KIM

Mayor Eric Adams has appointed Kevin D. Kim to serve as the commissioner for the NYC Department of Small Business Services (SBS), making him the first Korean American to hold this position. The SBS is an agency committed to promoting economic self-sufficiency and mobility for New York City's

diverse communities through fairness and equality.

Commissioner Kim's appointment has provided the Korean American small business network with a much-needed and valuable point of contact. Recently, Senator Chuck Schumer appointed Commissioner Kim to serve on an eight-person commission responsible for studying the creation of a National Museum of Asian-Pacific American History and Culture. The commission will submit a report to the President on the potential establishment of the museum.

In February 2022, Commissioner Kim was sworn in as a member of the President's Advisory Commission on Asian Americans, Native Hawaiians, and Pacific Islanders. He received his B.A. and M.A. from Stanford University and his J.D. from Columbia Law School, where he was a member of the Columbia Law Review. Commissioner Kim's extensive experience and knowledge make him an asset to these critical advisory roles.




